Clinton College Student Consumer Information

The faculty and staff at Clinton College are committed to providing educational opportunities to all students. Under the Americans with Disabilities Act (ADA) a person with a disability is defined as:

"Any person who (1) has a physical or mental impairment which substantially limits one or more major life activities, (2) has a record of such impairment, or (3) is regarded as having such impairment."

The Americans with Disabilities Act states:

"No qualified individual with a disability shall, by reason of such disability, be excluded from participation in or be denied the benefits of the services, programs, or activities of a public entity [college], or be subjected to discrimination by any such entity."

It is the policy of Clinton College to abide with ADA requirements and city inspection regulations for access to facilities and equipment. The services for students with disabilities are designed to ensure full access to programs and services. The Americans with Disabilities Act

of 1990 upholds and extends Section 504 Of the Rehabilitation Act of 1973. Title III of the ADA states:

No individual shall be discriminated against on the basis of disability in the full and equal enjoyment of the goods, services, facilities, privileges, advantages, or accommodations of any place of public accommodation by any person who owns, leases (or lease to), or operates a place of public accommodation. (42 USC 12182)." Clinton College does not discriminate on the basis of a handicap in violation of Section 504 and the regulations implementing it.

All students are responsible for meeting the qualifications set forth by the College for its courses, for their own academic achievements and for meeting and maintaining the essential academic standards of the College. It is up to the students with disabilities to seek services when needed and to use agreed upon academic accommodations. All students with certified disabilities should contact the Student Support Services (SSS) Program.

"Uploading or downloading works protected by copyright without the authority of the copyright owner is an infringement of the copyright owner's exclusive rights of reproduction and/or distribution. Anyone found to have infringed a copyrighted work may be liable for statutory damages up to \$30,000 for each work infringed and, if willful infringement is proven by the copyright owner, that amount may be increased up to \$150,000 for each work infringed. In addition, an infringer of a work may also be liable for the attorney's fees incurred by the copyright owner to enforce his or her rights.

The following are examples of misuse of computing resources in the context of illegal downloading and file-sharing:

- Unauthorized duplication, distribution or alteration of any licensed software. This includes software licensed by the university and licensed software accessed using the computing networks.

- Attempting to gain unauthorized access to any computing resource or data or attempting to disrupt the normal operation of any computing resource or network -- at Clinton or anywhere on the Internet.
- Knowingly infecting any computing resource with a software virus. Using college computing or network resources for personal gain or illegal activities such as theft, fraud, copyright infringement, piracy (e.g., sound or video recording), or distribution of child pornography or obscenities.

"No student shall allow any person to use his/her ID and/or password, create access into the computing network in such a way that will bypass College security systems, attempt Refund copyrights while using College equipment, or use computing services in any way which may violate federal, state, or local law."
